Maintenance

Organizational
Maintenance

Perform organizational maintenance, beyond the tenant crew chief capability, for support aircraft only.

Perform organizational maintenance for mission aircraft and furnish a crew chief for support aircraft.

Medical
Services

Provisions of AFR 11-4A apply except that the host will not maintain medical and dental records of tenant military personnel. As clarification, the host will furnish the tenant medical supply items on a reimbursable basis.

Provisions of AFR 11-4A apply and the tenant will maintain medical and dental records of tenant military personnel.

Supply	Provisions of AFR 11-4A apply except that Engineering Data and Explosive Ordnance Disposal are not required by tenant and supply support for aircraft will be only for support aircraft. As a matter of clarification, equipment and supplies will be provided on a non-reimbursable basis in accordance with Hq AFSC (SCCPM) letter of 24 July 1967. Ground
Safety

Implement and conduct a ground safety program IAW AF and AFSC directives in the 127 series as well as AFFTC safety directives. Include tenant personnel in the Traffic Safety Training Program conducted IAW AFR 50-24. Investigate and report ground accidents IAW AFR 127-4, involving tenant personnel and equipment which occur outside the tenant restricted area. Tenant accidents and exposures will not be consolidated with those of host. Conduct accident prevention surveys (AFM 127-101) for the tenant facilities outside the tenant restricted area on the same frequency as host units.

Comply with the AFFTC safety program IAW applicable USAF, AFSC and AFFTC safety directives. Coordinate tenant activities with the host Ground Safety Director. Advise host of occurrence of ground accidents whether inside or outside the tenant restricted area. Investigate ground accidents that occur inside the tenant restricted area. Forward accident reports to parent command. Prepare AF Form 740 and forward copies to host base and tenant parent command.
